OWASSO FARMERS' MARKET RULES & AGREEMENTS

1. I agree to abide by all market rules including the requirement that ALL produce will be Oklahoma grown and I will grow at least 70% of the produce & the other 30% will be picked by me the vendor. And agree that I may be subjected to a garden/farm inspection at any time.
2. I agree to have all food, buckets, coolers, or anything else used for produce to be at least 6 inches off the ground to abide by the Oklahoma Health Dep't Rules and Regulations.
3. I agree to be at the market and set up at least 10 minutes before the market begins & stay there during the duration of the market hours **and will not start selling until the official start time and will not start breaking down until official ending time.**
4. If I am selling any edible product I agree to give a copy of my Health Dep't Permit to the market manager before I set up for sale.
5. I agree to have at least one table in which to sell at, not park my vehicle at my table, and keep my booth clutter free, which includes picking up all traces at the end of the market day.
6. I agree to pay my annual fee of \$15 per booth and 10% of my daily gross sales not to exceed \$10 per business due before close of that market day.
7. All arts and crafts must be preapproved by board members.
8. I also understand I am responsible for my own taxes.
9. **I understand my membership in the association can be revoked at anytime if I intentionally misrepresent my products or intentions.**
